Position: Early Childhood Development (ECE Educator) at Kensington Preschool Program

Cedar Cottage Neighbourhood House is looking for an energetic Early Childhood Educator (ECE) who enjoys being part of a new child care team, and is passionate about working with young children in an inclusive and quality Reggio Emilia inspired preschool environment.

The ideal candidate has their ECE license or is currently enrolled in a recognized Early Childhood Education program. The position requires good understanding of (and a willingness to learn) the Reggio Emilia approach, including implementing daily inquiry-based explorations. The role requires direct interaction, planning, guiding and caring for children, and engaging with families.

Qualifications:

- 1 year experience working in a licensed child care or preschool program.
- A valid Early Childhood Education (ECE) Certificate or equivalent. If holding equivalencies, must be willing to enrol in an ECE program.
- Knowledge of the Child Care Regulations Act.
- Current First Aid Certificate.
- A satisfactory vulnerable sector Police Record Check (CRC).
- Demonstrated ability to plan and implement dynamic and safe activities (including COVID-19 safety activities) in a Reggio Emilia inspired program.
- Proven experience working in a multicultural environment.
- Current Food Safe Certificate is an asset.
- Languages other than English are an asset.

Start Date: As soon as possible.

Employment Terms: 35 hours per week, Monday to Friday. This work is done in-person and not remotely. Cedar Cottage Neighbourhood House adheres to all COVID-19 protocols.

Hourly Wage: \$19.51 to \$20.66 per hour (Shared Cost benefits package after 3 month, including a company pension after 1 year of employment).
