We are seeking a highly motivated, passionate, flexible, and compassionate individual to join our dynamic child care team as a Temporary **Infant Toddler Educator to work in our Infant Toddler program at the Village @ Lord Nelson located at 1355 Garden Drive, Vancouver.**

About the Position

The Infant Toddler Educator is a temporary position and responsible for the provision of an early learning and care program that fosters a positive, and emergent learning environment with a focus on the social and emotional well being of all children. We are an inclusive, multicultural, dynamic and collaborative child care setting which includes working with other educators to plan and implement a progressive and innovative program inspired by the Reggio Emilia approach, BC Early Learning Framework in concert with the values of FHNH. Other responsibilities include developing strong and collaborative relationships and communication with children, families, and colleagues. This position works in the Infant Toddler program at the Village @ Lord Nelson or in other childcare program as need arises.

We are a Learning Centre (www.reggiolearning.ca) with amazing opportunities for professional development and for collaborative efforts with other educators and with the community.
